

# **Annual Information Report for Supported Missionaries**

You may already have written resources which will answer certain items (e.g. personal testimonies, support schedules, annual reports); you can just attach copies of those resources, directing our attention to them appropriately on this form.

Your sending agency or other churches may have annual report or questionnaire requirements. Go ahead and use those other materials to reduce the burden of filling out this report.
- 4. Most of the items will only have to be filled out the first year, with only significant changes noted annually. Attach other pages to this form as necessary. Submissions in electronic format are acceptable and even desirable.

If there are special instructions regarding Customs Duty or hand-carried items, please let us know.

- a. We request that each husband and wife relate to us a brief testimony of their personal salvation.
- b. Likewise, would each of you please give us a brief account of your ministry calling?
- c. Let us know your ministry experience and development prior to being accepted or appointed as a missionary.

### 3. Home/Sending Church and Sending Agency

- a. Through what agency are you sent to the field?
- b. To whom do you report on the field? Stateside?
- c. Do you have a regular annual (or quarterly?) report or evaluation for your agency or sending church? If so, we request that you supply a copy to us, also.
- d. Please describe the level and structure of administration over your ministry.
- e. Do you have concerns about your leadership and/or team and/or mission administration which should be a matter of prayer or concern to us?
- f. Are there significant areas of incompatibility of which you are aware between your agency or sending church and our church? If so, please explain.

#### 4. Doctrinal Orientation and Compatibility

- a. How would you describe your personal theological orientation within the spectrum of evangelical doctrine and practice?
- b. Do you have a personal "doctrinal statement" or "statement of faith"? If so, please attach a copy to this form. If not, please don't create one just for this request.
- c. Please attach a copy of the "statement of faith" of your sending agency or church and explain in what ways, if any, you may differ or interpret parts of differently than a straightforward reading might imply.
- d. Please read our attached doctrinal statement.
